THE OPERATIONAL REPORT

As duty activities continue to slowly increase nationwide, it's essential to discuss the proper setup of first aid posts. Rather than providing a traditional report this month, we'll focus on ensuring that our first aid posts are well-prepared and tailored to meet the demands of our clients and duties.

Understanding First Aid Posts

A first aid post is defined by the specific requirements of each duty assignment. Depending on the scenario, this could range from using an ambulance as the primary first aid post to setting up a designated room or simply creating an organised space with tables and chairs. Regardless of the setup, certain fundamental principles should guide the establishment of any first aid post.

Firstly, maintaining neatness and organisation is vital. A clean environment instills confidence and allows for efficient operation during emergencies. Secondly, all equipment must be routinely checked and kept in working order to ensure readiness when needed. It's crucial to research the particular event you'll be attending, preparing for injuries that may be related to the activities involved. Finally, a proper waste disposal method, such as a container or bag. should be established to manage medical waste responsibly.



Ambulance Setup

When an ambulance serves as a first aid post, it should be tidy and free of unnecessary equipment. Personal items must be securely stored away in the designated compartments. It is important that the ambulance be parked in a manner that allows it to be easily seen and identified by responders and casualties. Moreover, it should be parked in a manner that allows for swift departures in emergencies.



Outdoor First Aid Post

When setting up an outdoor first aid post, it is crucial to protect it from the elements, like wind and rain, while

ensuring privacy for those seeking assistance. Ideally, the area should be enclosed and equipped with stretchers or blankets as makeshift beds. A table for medical equipment and chairs for casualties will enhance comfort and organisation. Make sure to include a medical waste bag or sharps container, establish an area for personal belongings away from the treatment zone and ensure proximity to toilet facilities and handwashing stations whenever possible. If there is some choice on the precise location, it is also essential to make sure that the area is well signed where possible so that the public can easily find the post when needed and event organisers and other personnel working at the event/duty are aware of the location.



Indoor First Aid Room

The optimal choice for a first aid post is a dedicated first aid room, which can be easily arranged as a medical facility. This space should ideally include beds and chairs, along with sheets and pillows for patient comfort. If not already in place, consider adding

screens for privacy; excess blankets or sheets can be hung to assist in this matter. As with outdoor first aid posts, access to toilet facilities and handwashing stations are important. However, with indoor first aid posts comes greater access to electricity. Give some consideration to possible equipment on site which could be moved into the first aid post and may enhance the functionality of the room/ post, for example, additional lighting, a heater for warmth or a fridge to store cool packs and other temperaturesensitive equipment/supplies. Finally, do not forget a medical waste bag or sharps container to ensure safe disposal of hazardous materials.



Properly setting up first aid posts is critical in ensuring we can provide effective care during events. By adhering to these guidelines, we can enhance our readiness and overall effectiveness as first responders. As we prepare for the upcoming duties, let's work together to create

safe, organised and efficient environments that reflect the high standards of care we aim to provide.

THE MEDICAL REPORT

Continuing
Professional Development

(CPD) points are essential for maintaining professional competence and ethical practice among healthcare practitioners. If you wish to maintain your qualifications and be able to practice in South Africa, you need to obtain a certain amount of points each year and have them logged with the Health Professions Council of South Africa (HPCSA). This month I am going to talk a little bit about CPD points and important updates that you should be aware of.

What is CPD?

CPD points, are credits earned annually and logged with the HPCSA through attending or partaking in a range of learning experiences designed to enhance the knowledge and ethical attitudes of medical professionals. Beyond initial training, CPD ensures practitioners stay current with industry standards and best practices. It plays a vital role in conforming to legal, regulatory and ethical standards, promoting transparency, accountability fairness in healthcare in South Africa. While our basic first aiders and homebased carers are not required to obtain or meet CPD point requirements, these points become critical for those with more senior medical qualifications. Understanding CPD requirements specific to your qualification is crucial to maintaining your potential to

practice. For example, a differing number of points is required for different healthcare and allied healthcare professionals. The HPCSA website provides more details on the specific requirements (i.e. number of points) required annually for each qualification. The Brigade regularly posts notices on our national Facebook group and in several Officer WhatsApp groups of opportunities to obtain CPD points, with numerous taking place online and thus widely accessible to all irrespective of your province or district. Do join our Facebook (https://www.facebook.com/ group groups/866625727383580) to keep regularly updated or ask your officer about upcoming CPD opportunities to ioin.



Recent Announcements



For those of you who have perhaps fallen short on points for this past year, the HPCSA announced a three-month extension for practitioners to rectify their CPD compliance, effective from 1 April to 30 June 2025, to catch up and meet their obligations. Again, do join our Facebook group to keep regularly updated or ask your officer about upcoming CPD opportunities to be informed:

South African Nursing Council (SANC) has also recently introduced a CPD framework for nurses and midwives, mandating these practitioners accumulate 15 CPD points annually too. This initiative is designed to promote lifelong learning and enhance professional competence, ultimately ensuring safe and ethical nursing practices. If you were not aware of this, it is important that you familiarise yourself with these new requirements.



At St John Brigade, I believe that CPD is not merely a checkbox but a commitment to excellence and continuous learning. As healthcare professionals, we need to proudly uphold our standards and strive for the highest quality of care.

Mentorship and reflection are also vital components which our divisional officers need to think about. I am committed to creating a robust mentorship programme that ensures a continuous pipeline of leaders. Through SYAN and district advisory networks.
